BPW Thimi: Activities January – August 2008

Business and Professional Women Thimi is engaged in tailoring training including other regular programs.



BPW Thimi conducted basic tailoring training class for the girls in Madhyapur, Thimi. Total of 18 girls had participated in the training. The training was given by Purnima Prajapati, executive member of BPW Thimi. The training was conducted from 15th April 2008 and was of three months duration.

BPW Birgunj: Activities January – August 2008

Under the project "Poverty reduction through socioeconomic activities" for 2008, the classes was delayed by one week because of the continous festival season. The literacy class has been completed in all four sites. The targeted women are very much interested in learning and enjoyed the class. Awareness trainings such as health, environment and social awareness has also been completed, so the women got to know a lot about health and hygiene and society. As a part of skill training, candle and incense making training has been completed in all targeted areas. The sewing cutting training was conducted on Bhadra 30 -

31, 2065 in Nagardha and Padhmole with 10 -12 women. The women are very happy that they got the skills so that they could earn their living. And for micro-credit, BPW Birgunj planned to invest Rs. 2000/- as seed money for each saving groups and there are 10 groups in total. For the better followup for the saving groups, we have collected the information about the family's income source, their house and land's ownership and about where the money can be invested for better income etc. The project in a whole has bee implemented with better output for this year.

BPW Biratnagar: Activities January – August 2008

"Poverty reduction through socio-economic activities" has been implemented in 4 wards of Morang District viz. Ghinaghat, Baijanathpur Jhapa, Sambhaha and Amahi. We selected these sites as the women here were under poverty line because of illiteracy, lack of awareness about health and hygiene, laws and rights, unemployment, domestic violence etc. Baseline survey was conducted in these sites, with the help of questionnaire to know what the situation of the villages is and what would be useful there. Total 120 women, 30 from each wards were selected with the objective of uplifting their social and economic status.

Our first step was to train the teachers who could teach the illiterate women. 8 women were chosen for TOT and were

taught the tricks to teach Naya Goreto I and II. Then from April 2008, the literacy classes were started. While the women were learning how to read and write, we thought it would be better if we could give them training on social awareness, health and hygiene and environment. They were taught the awareness about community development, gender and gender equality law, leadership development, selfdependency and human rights. Plus the importance of Vitamins, nutrition and malnutrition, safe motherhood, first aid, home medicines, water cleaning methods, water borne diseases, reuse of water, vaccination, HIV Aids, bad effects of plastic use on environment and importance of environment. The step further was to uplift their economic status by giving them skills so that they could earn for their living and for their families. 4-day skill training such as candle and dhoop making started in August 2008. The 4 day Sewing Cutting training is being given to the women since 2061 by BPW Biratnagar. One day interaction programme was organized by BPW Biratnagar where Dr. Dilli Devi Shakya and Ms. Laxmi Keshari Manandhar, from FBPWN evaluated and interacted about the programme. While looking back into the activities of one year, we are content that at least 120 women who were under poverty line, now can raise voice for their rights and can make their living on their own. Hopefully, we can work for more women next year.

BPW Ramechhap Activities January – August 2008

Ramechhap BPW, from it's establishment period, has been conducting various programmes. It has been working on women related issues, such as awareness raising, skill training, forming women co-operatives group, community infrastructure development and these works has set our chapter as a role model organization for other Government and non-government organizations.

Activities:

- 1. Published informative wall magazines in 3 primary schools through the project "We Can."
- 2. Elocution in 3 primary schools about women violence.
- 3. Street drama at Manthali against women violence.
- 4. Hoarding Board- 2 hoarding boards are being displayed against women violence in the market centers.
- 5. The 16-days programme against women violence was held with the joint effort of INSEC.
- 6. An interaction programme about the current scenario of human right was held at Manthali in association with Advocacy Forum.
- 7. A peace rally was taken out along with Human right peace community.
- 8. A Candle lighting ceremony was organized to celebrate Human Right day.
- 9. 10 groups of women farmer were formed and group activities are being conducted.
- 10. 190 families from 182 houses are benefited.
- 11. A training was organized about seasonal and unseasonal vegetables for those 10 groups and seeds of the vegetables were distributed.
- 12. A 3-meter long irrigation tunnel is in the final stage of completion.

BPW Pokhara Activities January – August 2008

BPW Germany invited Ms. Laxmi Gurung, Coordinator of BPW Pokhara to visit Germany from 2065.2.17 till 2065.3.6. Ms. Laxmi Gurung thanked BPW Germany for the invitation and BPW Pokhara wished her nice journey. The computer literacy training is being conducted on a regular basis and till now 80 women have been graduated and 23 women are taking classes now. The life member Ms. Ras Kumari Gurung, on returning from USA donated Rs. 10,000/- to BPW Pokhara. Ms. Anar Bhari, Treasurer particapted the inauguration program of Muktinath Development Bank on 2065.2.24. In joint effort of BPW Pokhara and Richmond Fellowship, one day programme was organized with Mother's Group against Drug trafficking. We discussed the idea of women telecenter with country manager Dr. Rohit Nepali of M.S.B. K Nepal where importance of computer literacy for every member of Pokhara chapter was also discussed. On 2065.3.28, we organized a discussion programme on establishment of telecenter with some distinguished guests. We celebrated 23rd Annual General Meeting with an interaction programme on "Women involved in service and business." On Children's day, we distributed sweets and clothes to the children of Child Care Center opened by FBPWN in Pokhara Industrial District.

The XXVI BPW International Congress Power to Make a Difference, Mexico city, Mexico

B PW International Congress is held every 3 year in different cities around the world. The XXV BPW International Congress was held in Luzerne city, Switzerland where it was decided that XXVI BPW International Congress will be organized in Mexico City, Mexico with a theme "Power to make a Difference " from 24th to 28th October, 2008.

Mrs. Ambica Shrestha, President FBPWN, I Santa Sharma, Treasurer, FBPWN and Mrs. Ganga Adhikari, member Kathmandu BPW represented BPW Nepal at the 26th BPW International Congress. I was the lucky enough to receive funding support from International Aid fund from South Asia region. I got economic support of Euro 1000.00 from the aid. Mrs. Ambica Shrestha, also being member of IBPW'S Executive Board, left to Mexico City on 20th October from Mexico City. The conference was organized at the 5 Star Gran Melia Mexico Reforma Hotel from 24th October from 8am. The programs like presentations, business and plenary session were being run parallel at the same time from 8am to 5pm, so it was difficult for the participants to attend every programs. We were bound to miss the programs.

The participants form counties from different parts of the world like America, Canada, China, Korea, Finland, Iotion America, Thailand, Africa, Mexico, Arch State, Australia, Italy, Pakistan, Haiti, European Countries, Taiwan, Switzerland, Germany, Japan, New Zeeland were present at the International Congress. The attraction were the delegacies from UN, UNICEF, FAO etc, and past president of BPW International Sylvia Perry, Attony Ruegg, Dr. Yvetteswan.



The program started with registration and regional conference on 24th October and there was Grand Opening Ceremony of the Congress in the afternoon at the old Government Office with music and entertainment. Every participant representing their county with their country's flags entered the hall. Our president, Mrs. Ambica Shrestha, also entered the hall with flag of Nepal. She looked so young and enthusiastic with our flag in her hand. There

was Presidential Party, but we had nothing but water.

On 24th October, many resolutions were passed at the congress like constitution of BPW International, By laws which can be found on

www.bpwinternational.org. on the same day, the XXVII Congress meeting venue was decided as Helesinki, Finland.

From 26th October, in Mexico City, the local time had been adjusted to minus one hour which was notified in our program manual. But we reached the hotel one hour earlier as we were unaware about the time adjustment. That day only, we got some refreshments such as tea, coffee and cookies from the organizers. In spite of member's registration fee of US\$ 460, we

FBPWN's Projects

Mrs. Babita Rana, Project Director

1. Business Service Centre (BSC)

The Business Service Centre (BSC) is a four year project of The Federation of Business and Professional Women of Nepal (FBPWN) with the technical assistance of the Italian Association for Women in Development (AIDOS). The BSC project launched in February 2008 is co-financed by the European Commission (EC).

The Project aims to enhance women's active role in the labour market through the upgrading of existing micro enterprises run by women into more viable, self-sustainable and growth -oriented businesses and through the creation of new ones. By doing so, the Project intends to contribute to mitigate the poverty affecting Nepalese families by enhancing women's capacity to organize their labour in an economically feasible way.

The BSC covers the following areas: FBPWN's Kathmandu, Patan and Thimi Chapters, Kirtipur Municipality and Nuwakot District. The Project targets disadvantaged, poor women (between the age group 18-50 years) who are residents in the target areas. Preference will be given to female heads of household and family breadwinners and those already involved in business activities or intended to start an entrepreneurial activity.

The BSC acts as a counselling / training / business

development centre to support women's led subsistence income generating activities to become more viable, and profitable. The BSC is managed by a technical team including: a Director, a Training Coordinator, a Marketing Officer, a Business Counsellor/Credit Officer, and two Local Promoters. The BSC Team is trained by AIDOS outsourced international experts in the field of enterprise development, marketing and communication and Product Design and Development and it is supported on-the-job by the International Project Manager (AIDOS) and the National Project Manager (FBPWN).

The BSC provide existing and potential women's MSEs in the Project target areas with an integrated package of business development services (BDS) including: entrepreneurship orientation, business management training, technical skills training, product design and development (PD&D), facilitation to access micro and small credits, follow-up and business counselling, marketing assistance, and business networking. The BSC will also offer, on a contractual basis, technical assistance and capacity building services for organisations involved in local socio-economic development. The BSC is established as a donor–funded development cooperation Project. However, the Project will work to define an appropriate sustainability strategy to establish the BSC as a permanent centre of excellence for the promotion of women's entrepreneurship in Nepal.

2. Poverty Reduction through Socio-economic Activities

Dr. Dilli Devi Shakya 1st Vice-President and Project Coordinator

Federation of Business and Professional Women Nepal (FBPWN) has always been working towards empowering women socioeconomically and leadership potential at all levels. FBPWN has been working on several projects that help girls, children and women mostly in the urban area. Since the year 2002 FBPWN has been helping village women under the project "Poverty Reduction through Socio-economic Activities" supported by Leger Foundation, Canada. Poverty exists more serious in hills and terai of Nepal because of deep rooted male dominated traditions which is one of the main factors. The target women beneficiaries are illiterate disadvantage groups. The package of project activities includes functional literacy, skill trainings, and awareness trainings in social, political/legal, gender equality/equity, environment, health/hygiene and saving credit so that they can run small business.

In the year 2002 to 2005, the project had been implemented in Village Development communities, (VDCs) of Chapali Bhadrakali of Kathmandu, Saibu Bhaisepati of Patan and Sirutar of Bhaktapur districts. The target beneficiaries are illiterate disadvantage women farmers and they are small farm holders. The project activities designed for these farmer women include mainly agricultural skill trainings covering organic composting, soil types, crop diseases pesticides use and health hazard, bio pesticides, off season vegetables and quality seeds besides literacy.

Year 2007 to 2010

In the year 2007 to 2010 the project has been implemented in Katahari, Baijanathpur and Tankisinwai VDCs of Biratnagar, Morang district and Udaipur Ghurmi, Nagarhada and Bairiya Birta VDCs of Birjung, Parsa district through BPW Biratnagar and BPW Birjung chapters of the Federation respectively. The target beneficiaries of terai are very poor, illiterate disadvantage landless women of heterogenic ethnicity. The landless terai women are very poor and they are mostly laborers in agricultural. The scenarios observed in villages of terai are quite different from the villages of periphery of Kathmandu valley where they have their own land. So instead of agriculture training, other skill trainings like incense sticks and candle making and sewing cutting have been provided along with literacy, awareness programs and capacity building. The literacy, skill trainings and micro credit are the important components of the project activities.

Impact of project or change

The target women of sixteen villages have already completed various trainings by the year 2008. The overall changes are remarkable. They became literate and are happy that they can read and write simple numerical. They feel proud that they are now self confident and can share their opinion with their family and community. They have become health conscious. In villages, wives are blamed if they gave the birth of girl child only. Now they came to know that the birth of a girl is not only the defect of wife alone it might be due to her husband. Skill trainings have

helped them to be able to make small income generation. They are able to do small business. Some women beneficiaries are saying that their husbands are eventually found supportive. Some of them have been hired by other NGOS as the trainers for making candles and incense sticks trainings. Some are running home based tailoring. They are happy and satisfied to be with BPW activities. They used to say to their village community that BPW is different.
